## **Past President's Report Chip Burns - Texas Christian University**

Hello SWACJ.... I hope you returned safely from the annual meeting in Fort Worth. We certainly made the most of a difficult situation when forced to relocate our meeting. I hope all enjoyed the meeting. I wish to begin by commenting on the quality of the presentations and the level of student involvement at the meeting. Numerous attendees commented to me on the high quality of research presented at the meeting, and for that I thank all who presented. I had the pleasure of sitting in on a few panels and I concur. Great stuff. I was extremely pleased with the level of student involvement at the meeting. Our impressive students were thoroughly involved with the meeting from Thursday afternoon's Undergraduate Quiz Bowl through Saturday's presentations. My unofficial tabulation of program participants suggests 79 of the 175 (45%) names on the program were students. I was also encouraged by the level of practitioner participation in the meeting. Representatives from five separate non-academic entities presented papers, and numerous others attended but did not present. SWACJ should continue encouraging practitioner involvement. Thanks to all who contributed to the Tory Caeti Fund. We raised \$234 for Tory's children. Special thanks goes to Bob Taylor and Wes Johnson for the kind words shared during the tribute to Tory at our Past President's Reception.

Upon assuming the SWACJ Presidency I made a list of things I wished to accomplish. Tops on the list were to select a new editor of our journal and to revise the SWACJ Constitution. Toward this end, Will Oliver and Wes Johnson were selected as editors and have done an outstanding job with the Journal's development. As you know, the revised constitution was approved at the annual meeting. I am thankful to all who assisted with these tasks, particularly the ad-hoc Constitution Committee consisting of Joy Pollock, Camille Gibson, and Phil Rhoades. ### **Tracy Andrus, 2<sup>nd</sup> Vice President Wiley College**

Dear SWACJ Members,

I pray that this letter finds all of you in the best of health as we focus on the completion of our fall semesters. I want to first thank all of you for your votes of confidence in me during the annual meeting in Ft. Worth. It is my sincere desire to serve SWACJ to the best of my abilities. I would like to take this time to tell you a little about myself and ask for your assistance in helping me to decide on a site for the 2008 conference.

I am from Crowley, Louisiana and graduated from high school with the class of 1981. I am the 12<sup>th</sup> child of Alice and the late Warren Andrus Sr. I developed an interest for criminal justice after having spent three years in the Louisiana Department of Corrections from 1991-1994 for check kiting. While in prison, I decided that I did not want to spend the rest of my life or

any additional time locked up in prison. Once released on March 23, 1994, I started working and enrolled in Louisiana College, Pineville, Louisiana in the spring of 1995. I graduated from Louisiana College with a Bachelor's Degree in Criminal Justice in 2000. I then attended and graduated from the University of Louisiana at Monroe with a Master's in Criminal Justice in August 2001. I entered Prairie View A&M University in September 2001 and became the first African American in the U.S. to earn a Ph.D. in Juvenile Justice on May 7, 2005.

I am the author of three books and am currently finishing my first CJ intro textbook; it should be available by fall 2007. I am the director of the Lee P. Brown Criminal Justice Institute at Wiley College and serve on several criminal justice committees and boards. My research interests tend to focus on ex-felons' rights, poverty and crime, the history of incarceration, and Marxist and conspiracy theories. Finally, and most important, I am married to Dr. Sonya Burnett-Andrus who is also part of the faculty at Wiley College. We have two children, ages 21 and 23, Desmond and Tracy, who are both students at Wiley.

One of my first duties as 2<sup>nd</sup> Vice President is to select the conference location for the fall 2008 meeting. I would like to ask your assistance in making recommendations for our site selection for that meeting. **Treasurer's Report**

This year, SWACJ had a record 176 individuals/organizations as participants in the Fort Worth meeting. As of this writing, I have processed \$12,775 in conference related fees. Of note this year is that sponsors played a major role in the amount of money brought into the organization. Our overall total received and processed to date is \$13,035.00. The amount of known conference related expenses incurred was \$8,917.92. Subtracting the expenses from the monies received and processed brings the total processed profits from the conference to \$4,117.08. There is still \$2,480 outstanding in monies owed to SWACJ from conference participants and a detailed list has been completed on all monies.

As of 11/10/2006, we have a balance of \$10,095.21 in savings and \$13,826.48 in savings for a total of \$23,921.69.

**SWACJ Annual Meeting Minutes, Ft. Worth, September 29, 2006**

Chip Burns called the meeting to order at 4p.

Chip briefed the assemblage on the voting procedure for officer elections and the new constitution.

He thanked the past year's officers.

He thanked the constitution revision committee.

He thanked all those who had helped in one form or another during his year as president.

He asked for contributions to the Tori Caeti fund.

Chip then turned the meeting over to Will.

Will presented Chip with a plaque commemorating his service to the Association with our thanks for a job well done.

Will announced elections for the position of both first and second vice-president.

He described the duties of both positions.

He then opened the floor to nominations for first vice-president.

Pat Mueller nominated Phil Rhodes citing how much work Phil had already put into planning next year's meeting in Corpus Christi. This nomination was seconded by Dorothy Bracey.

There were no other nominations. The motion was made, seconded, and passed that nominations be closed. This act elected Phil to the position of first vice president.

Will then opened the floor to nominations for second vice president.

Lori Rubenser was nominated by Wes Johnson, seconded by Albert Keys.

Tracey Andrus, sr. was nominated by Michael Champion, seconded by Andrea Talley.

Phil Holley was nominated by Chip Burns, seconded by Harrison Watts.

Wes Johnson moved that nominations be closed; this was seconded and passed.

Paper ballots were issued, collected, and counted by Tom Darden and Phil Rhodes.

The initial vote resulted in a technical tie forcing a second ballot between Lori Rubenser and Tracey Andrus, sr.

Tracey Andrus won the second ballot.

Will then gave Chip the floor for the ACJS trustee's report.

This report is printed elsewhere in the newsletter.

Will presented the treasurer's report, David being absent.

Wes motioned the report be accepted as read; motion seconded and passed.

Will reported on the Association's journal advising that Napoleon Reyes was the new managing editor. Will announced that as part of the agreement with SHSU, a limited run of printed copies of the Journal would be available. Will had copies available for distribution. He advised the spring on-line edition would be available in hard copy at each fall's SWACJ annual meeting and the fall on-line edition would be available in hard copy at the ACJS annual meeting each spring. He repeated the call for papers.

Will recognized Lori Rubenser as the co-editor of the ACJS Police Journal.

Will announced that next years meeting would be held in Corpus Christi and that Phil Rhodes was on-site coordinator. He then gave Phil the floor. See Phil's letter.

Phil yielded the floor to Will who announced that sight selection for the 2008 meeting would occur at the ACJS meeting this spring. In keeping with the policy of two years in Texas followed by one year elsewhere in the region, the 2008 meeting will be held other than in Texas.

Will recognized the two state associations, Oklahoma and Texas, and stated that their association meetings would occur at 5:30p. Will stated special recognition was in order for the Oklahoma folks who had built an association since this time last year.

Will gave Chip the floor for discussion and voting on acceptance on the revised constitution.

Chip had developed a rather complex plan for voting on each change individually using an elaborate paper ballot. After explaining the revisions and the voting process, Wes motioned that the revised constitution be ratified *in toto* by a voice vote. There were too many seconds to this motion to document; however Pat Mueller's was the loudest so he is the second of record on this motion. The motion to ratify the new constitution passed unanimously.

Will recognized Wes who thanked Chip and Pat for a job well done in this year's annual meeting.

Will asked if there was any other old business.

There being none, Will asked whether there was any new business.

Tomi Lee Grover asked for the floor. Professor Grover stated that a group of interested persons were petitioning ACJS to form a "Restorative Justice" section. She asked that persons sign on to the petition. She also advised there will be a national restorative justice conference in San Antonio. A motion was made by Will to adjourn. Again there were numerous seconds to the motion. Motion passed.

Identify the level of students most likely to find the book useful.

Reviews should be no more than three (3) single-spaced pages with references in APA style.
